I submitted my quote based on the information you gave to me that I should just send in the previous quote I had submitted. You didn't tell, or advise me you were going to competitively bid out the rail take up. You stated that I should submit my bids under \$21,000.00 so you could avoid the red tape and award the work. This way you could go forward with the project. Apparently, I shouldn't have taken your advise, I should have either bid it very competitively or not bid it at all. It almost sounds as if Railroad Resources & Recovery was set up to win this quote; you telling me not to change my previous quote and not telling me you had invited new contractors to bid the project. It appears the playing field got a little uneven at some point. I guess you just need to hope some contractor will build your siding for the amount of money you have to spend. As I recall, I was about \$129,000.00 lower than the next bidder. Good luck getting someone to build it as good as Track Builders would have for the price you need.
